

Water Festival



1/2 Cent Sales Tax Renewal

In the general election in November there will be a ballot item to *renew* the current 1/2 cent sales tax.

The 1/2 cent sales tax funds **52%** of the forecasted \$24 million spent each year on street projects.

The citywide sales tax program uses about \$14 million raised annually through a 0.5 percent

retailers' tax, also known as a sales tax. The funds are used exclusively for costs of maintenance and improvements of existing City of Topeka streets, gutters, curbs, sidewalks, alleys and street lighting.

Work continuing on:

- Microsurfacing- This year's project is winding down. Most, if not all work, will be completed by the end of business on Friday, Sept. 21.
 Some restriping may remain. The contractor completed 75 lane miles of microsurfacing in 8 weeks. Roads included arterials, collectors and residential asphalt streets.
- SW 37th between Burlingame and Kirklawn- The project was completed this week. The contractor has moved to SW 17th between Fairlawn and Arrowhead. Work is expected to be completed in about 2 weeks.
- Clarion Woods- Pavement removal and asphalt placement continues. Only small areas are removed and replaced at a time to reduce the distance residents must walk from their automobiles to their residences.
- SW Gage between 21st and 25th- A 24-hour shutdown period is planned from 6 p.m. Friday, Sept. 28, to 6 p.m. Saturday, Sept. 29, for a mill and overlay. The shutdown was approved to reduce construction time; provide a better finished product (smoother roadway); and save the City \$14,000 in construction costs.
 Businesses, the VA and residents will be notified of the planned closure. A message board will be placed on Monday, Sept. 24, to alert motorists of the plan.
- SE Adams between 29th and 33rd- Contractor prepared the outside lanes on the north end of the project for concrete placement, which is scheduled for next week.

- 21st and Kansas- The traffic signals are expected to arrive on Friday, Sept. 28. Northbound lanes of KS Ave are nearly complete.
- 29th and Burlingame- Work continuing on the southeast quadrant. Rework is necessary for the drive into the veterinarian's office. That work is to take place next week.
- Huntoon and Arvonia- Grading and retaining wall construction continues on the west leg. Next week they will work on ditch liners, median curb, sidewalks and ramps. That will be followed by concrete pavement.

Street Project Startup and Major Phase Changes:

- SW 29th Fairlawn to I-470 will start in September.
- Two alley projects will start within the next two weeks.
- Startup of the two mill and overlay projects.

of. Individuals were also able to get their drivers licenses reinstated.

The Topeka Community Foundation provided a \$3,500 grant to help people pay outstanding fines and fees.

Representatives from community organizations provided information about employment, housing and other services.

Recent Updates

- There have been 35 <u>water main breaks</u> in September with 638 breaks year to date. Last year at this time there were 277 total breaks.
- 57 dirt restorations for water main breaks have been completed this month with 359 completed this year. There are 163 pending dirt restorations.
- Neighborhood Relations staff cross trained with Housing and Credit Counseling so city staff and HCCI staff can make appropriate referrals and help more constituents with their needs.
- The Public Works Department filled 801 potholes this week.
