Topeka Police Department ID card initiative continues

In December 2018, the Topeka Police Department unveiled new identifications cards for individuals in the community needing a form of ID. This initiative had never been done in Kansas.

The purpose of the cards is to bridge the gap for the unsheltered or those who otherwise wouldn't be able to afford or have the proper documentation to apply for a state issued ID. The City of Topeka ID cards are free and available to anyone in need.

Topeka Police remind citizens of pedestrian and bicycle safety

A note from Topeka Police Lieutenant John Trimble

As the weather continues to get warmer, the Topeka Police Department is seeing more people outside walking, running and riding their bicycles in our beautiful city. I am Lieutenant John Trimble with the Topeka Police Department and I too enjoy biking throughout our city. While many of us like to take advantage of these opportunities to be outside, it is important to share with you some of the laws that are applicable to our pedestrians and bicyclists while in the city of Topeka.

 STO 63 states that pedestrians shall obey the instructions of any official traffic control device specifically applicable to them unless otherwise directed by a police officer.

- Another important part of the law is when traffic-control signals are not in place or not in operation, the driver of a
 vehicle shall yield to the right of way, slowing down or stopping if need be to so yield, to a pedestrian entering or crossing
 the roadway within a crosswalk. Simply stated, pedestrians have the right of way at crosswalks and traffic must yield to
 them.
- Where crosswalks are not available, pedestrians crossing the roadway are required to yield the right of way to all vehicles
 upon the roadway. Furthermore, between intersections where traffic control signals are in operation, pedestrians shall
 not cross the roadway at any place except in a marked crosswalk
- Lastly, pedestrians shall use sidewalks when they are available and practicable. If a sidewalk is not provided, pedestrians
 shall walk or run on the left side of the road towards oncoming traffic.

It is also important to remind the bicyclists of Topeka of the laws that pertain to them.

- Every person riding a bicycle upon a roadway shall be granted all of the rights and shall be subject to all of the duties
 applicable to the driver of a vehicle. In other words, bicyclists riding in the street are subject to the same rules of the road
 as vehicles.
- Bicyclists shall ride as close to the far right side of the roadway as practicable except when overtaking another bicycle or
 vehicle proceeding in the same direction, making a left hand turn, or when avoiding conditions in the roadway that would
 not be conducive for bicycle traffic. On certain roadways additional signs or markings may permit bicyclists to use special
 lanes or the full width of the lane of travel.
- The city of Topeka also recently approved the use of electric scooters on some city streets. Electric scooters are not
 permitted on any street with a speed limit of 35 mph or greater unless a marked bike lane has been designated for use.
 Riders of electric scooters must yield the right of way to pedestrians and give an audible signal before overtaking and
 passing a pedestrian.

It is also important to remind drivers that they should exercise due care to avoid colliding with any pedestrian, and shall give warning by sounding the horn when necessary, and shall exercise proper precaution upon observing any child or any obviously confused or incapacitated person. Please remember to stop your vehicle prior to entering a crosswalk when you have a stop light or stop sign. Look both ways prior to entering the crosswalk as pedestrian traffic can come from any direction. Be sure to give pedestrians, bicyclists and electric scooters three feet of space when overtaking them. You never know when a pedestrian or bicyclist will need some extra space because of something in the road.

Downtown Community Police Officer


Officer Matt Wilson
